

Fees

Fees for premises licences and club premises certificates are based on the rateable value of a property and rateable values are split into 5 bands, A to E. The fee payable for a licence or certificate is dependant on the band in which a property is placed, as in the table below. However, no fee shall be payable for an application for an educational institution, such as a school, college, etc. as long as the provision of the regulated entertainment carried on is for and on behalf of the educational institution. No fee is payable for an application for a church hall, chapel, or other similar building or community hall, parish hall or other similar building. **Payment of the fee is to be made to Blaenau Gwent County Borough Council.**

Premises fees

In the case of premises in Bands D and E, where the premises is used exclusively or primarily for the supply of alcohol for consumption on the premises, the following fees apply:-

BAND	FEE
D	£900 (£450 x 2)
E	£1905 (£635 x 3)

Where an application to vary the licence is made, the following additional fees apply:-

Where the number or persons allowed on a premises exceeds 5,000, the following additional fees will apply:-

An annual fee will be charged for every premises licence, as follows:-
