**(OFF – STREET PARKING PLACES
(CIVIL PARKING ENFORCEMENT AND
CONSOLIDATION) ORDER 2020****(AMENDMENT B) ORDER 2021
STATEMENT OF REASONS**

The amendment order is being introduced for the following reason:

To introduce a 'Control of Use' Order to ensure that parking bays within the named car park are used solely for the purpose they are provided.

It is also intended to gradually introduce Electric Vehicle parking bays within off-street car parking areas in Blaenau Gwent. To ensure that the bays are occupied solely by vehicles powered fully or partially by electricity for the purpose of parking and should it be necessary to allow the vehicle to be charged by electricity.

No other vehicle types will be permitted to park in the parking bays allocated with charging points. Other vehicle types will be permitted to park within bays not for the purpose of charging electric vehicles.

Blaenau Gwent County Borough Council (Off – Street Parking Places) (Civil Parking Enforcement and Consolidation) Order 2020, was an amendment to allow for the enforcement should any parking contraventions occur with the occupancy of use of spaces solely for the parking of Electric Vehicles.

The 'Control of Use' Order and electric bays are to be introduced in the following Car Park.

- Gwent Shopping Centre Treddegar
- Gwent Shopping Centre (2 bays for Taxis)
