# **1.0 INTRODUCTION**

- 1.1 This Consultation Report illustrates:
  - Conformity with the Community Involvement Scheme (CIS);
  - Who and how people were engaged during the different stages of the Plan's consultation;
  - The main issues raised through consultation; and;
  - How the consultation responses have affected the policies and proposals in the Deposit Plan.
- 1.2 Throughout this report, reference is made to other reports and documents which have collectively helped shape the Deposit Local Development Plan (LDP). These are not included in any appendices to this report as they are too lengthy, but copies are provided on the council website or by request by contacting the Planning Policy Team on 01495 354740/ 355538/ 355544/ 355501 or planningpolicy@blaenau-gwent.gov.uk

# 2.0 COMMUNITY INVOLVEMENT SCHEME

- 2.1 The Blaenau Gwent Local Development Plan Delivery Agreement (DA) was formally agreed by the Council and the Welsh Assembly Government (WAG) in May 2007. The agreed Delivery Agreement was revised with the approval of the Welsh Government in January 2011. The DA contains the preparation timetable as well as the Community Involvement Scheme (CIS).
- 2.2 The CIS establishes a framework for community and stakeholder engagement throughout the LDP preparation process. It seeks to ensure that engagement activities undertaken during the preparation of Blaenau Gwent LDP are inclusive, consistent and co-ordinated with the aim of providing a more transparent planning process.
- 2.3 Table 1 summarises the key stages of the Plan's consultation and community involvement actions committed to in the CIS.
- 2.4 The LDP has been produced in accordance with the provisions of the CIS and both the pre-deposit participation and pre-deposit consultation responses have helped shape the Deposit Plan's context and policy content.

# 3.0 WHO WAS ENGAGED AND HOW?

### Overview

- 3.1 All consultation organisations listed in Appendix 1 have been kept informed throughout the various stages of the Plan preparation process. Appendix 2 lists the Deposit Plan Representors and Appendix 3 lists the Alternative Site Representors. The Representors listed in Appendix 2 and 3 were kept informed of the forthcoming stages of the LDP preparation according to when they became involved in the process. Appendix 4, 5 and 6 lists each individual, organisation or representative that was invited to attend the different stages of the LDP process.
- 3.2 The Council has an LDP Consultation Database which contains a continually updated list of stakeholders, respondents and interested parties ranging from national umbrella organisations to local members of the public. Throughout the process all consultees on the database have been kept informed of the Plan preparation process.
- 3.3 There are approximately 500 consultees on the database, including 52 members of the public not associated with any stakeholder group or organisation. The methods used to raise awareness at both pre-deposit participation and consultation stages are identified above in Table 1 and are explained further in section 3.0 below.
- 3.4 Table 2 below shows a general overview of the number of people consulted with and the number of representations received at each stage of LDP preparation

# Stage 1: Pre Deposit Participation (Regulation 14): Vision, Key Issues and Strategy Options

3.5 The first stage of the plan making process was the pre-deposit participation stage. The principal aim at this stage was to establish whether a broad consensus could be reached on the key issues and strategy options on which the Preferred Strategy could be based.

Invitations for Expressions of Interest (Candidate Site Process)

# Purpose

3.6 The purpose of the candidate site process was to undertake early engagement with developers and landowners on potential sites to be included within the new LDP system, in order to avoid substantial numbers of additional sites coming forward at the examination stage.

# When? and Who?

3.7 In April 2007, the Council formally invited over 500 people on the consultation database (see Appendix 1) comprising of developers, landowners, agents, Council



departments, Local Councillors and others with an interest in land to submit sites they wished to be considered for development or reuse through the Local Development Plan for a range of uses, including housing, employment, retail, leisure, waste, transport, open space and other community uses. The deadline for the submission of sites for inclusion in the LDP process was 19<sup>th</sup> December 2008.

### How?

- 3.8 The Council formally wrote to those on the consultation database inviting them to submit land for consideration for inclusion in the Local Development Process. Attached to the invitation was a candidate site submission form, which the consultee was asked to complete and provide the necessary information, including a plan of the site.
- 3.9 An advertisement was placed in the Gwent Gazette on Thursday 10<sup>th</sup> May 2007 advertising the call for candidate sites. A copy is attached at Appendix 7. Information was also published in the Council's newspaper Valleys Voice, which was published in June 2007 and distributed to every household in Blaenau Gwent. A copy is attached at Appendix 8.
- 3.10 An advertisement was also placed on the Council's Community Communications Network which are screens located in key council buildings such as in libraries and leisure centres. A copy is attached at Appendix 9. A further advertisement was also placed in the Council Tax Wall Planner which is also distributed to every household in Blaenau Gwent.
- 3.11 Posters were placed in all libraries, civic centre and other Council buildings reception areas, community first offices and outreach venues. A copy of the poster is attached at Appendix 10.
- 3.12 All information on how to put forward sites including copies of the candidate site submission form were made available on the Council's website.
- 3.13 A series of ward member meetings were held In July 2007. The purpose of these meetings were to give members the opportunity to view the sites that had been put forward and identify any further sites.
- 3.14 This is fully compliant with the actions committed to in the Community Involvement Scheme as set out in Table 1.

### **Responses to the Candidate Site Process**

- 3.15 In total 187 candidate sites ranging in size were submitted for consideration. A candidate site register was prepared and published as part of the Preferred Strategy consultation.
- 3.16 The Council undertook a rigorous assessment of each of the candidate sites during 2008-2009. The results of the candidate site assessment process are contained in the Findings of the Candidate Site Assessment Process.
- 3.17 The information gained at this stage was integral to the formulation of strategic options for development across the County Borough.

**Issues Paper**

# Purpose

3.18 The Issues Paper (July 2007) was prepared as a discussion document intended to promote debate on the issues of strategic significance for the Authority.

# When?

**3.19** Formal consultation took place over a 4 week period between 6<sup>th</sup>July and 8<sup>th</sup> August 2007 with late responses being accepted.

# Who?

- 3.20 Copies of the Issues Paper were distributed with a covering letter and questionnaire to the following key external and internal stakeholder groups (see Appendix 4):
  - Blaenau Gwent Councillors
  - Key Internal Officers
  - Statutory Consultees
  - LDP Forum

# How?

- 3.21 Stakeholders were asked to respond to a series of questions on the:
  - Vision
  - Approach to sustainable development
  - Level of Growth
  - Location of development
  - Employment
  - Housing
  - Town Centres
  - Transport
  - Environment
  - Leisure
  - Tourism
- 3.22 The document was subsequently made available to other interested parties and members of the public via the Council's website. The Issues Paper Report of Consultation (September 2007) summarised the responses received, this information was then taken into account in the preparation of the options, and in determining the detail of the preferred strategy and Deposit Plan.
- 3.23 This is fully compliant with the actions committed to in the Community Involvement Scheme as set out in Table 1.

# Findings of the Issue Paper Consultation

- 3.24 This section summarises key findings from the consultation exercise on the Issues Paper:
  - An overwhelming majority of respondents recognised a need for a vision that should link to the Community Plan
  - No overall agreement on housing growth
  - Acceptance that some settlements are too small to accommodate growth
  - Agreement that growth should be focused on sustaining existing community areas



- Brownfield should not always be developed before Greenfield it should be about sustainability
- The Plan should cater for a range of densities
- The Affordable Housing threshold should be reduced
- The percentage of Affordable Housing should be dependent on site viability
- No overall agreement to reallocate employment land
- A more flexible approach to employment sites should be taken
- Vacant shops should be developed before further retail development is allowed
- The location of existing and future transport routes should be a key determinant of where future development is located
- It is important to protect the land of greatest biodiversity merit from undesirable development
- There is adequate protection of open space
- Tourism opportunities should be explored
- Waste Management was identified as an issue
- Education and Skills was an issue

# Issues and Vision Workshop

### Purpose

3.25 An Issues and Vision Workshop was held to discuss the issues, that is the problems the area faces, and to identify a vision of what Blaenau Gwent should look like in 2021.

# When?

**3.26** The workshop session was held on Friday 27<sup>th</sup> July 2007 at the ViTCC in Tredegar from 9.30am until 12.15pm which involved 27 attendees.

# Who?

- 3.27 The following representatives were invited to attend the Issues and Visions Workshop via e-mail and letter (see Appendix 5):
  - Key Internal Officers
  - Statutory Consultees
  - Other Consultees
  - LDP Forum

### How?

- 3.28 The workshop was separated into two parts. The first stage required attendees to collaboratively identify the main issues for Blaenau Gwent. They were then asked to prioritise the issues by topic area. They then prioritised all of the issues to identify the key challenges for the Strategy. During the second stage attendees were asked to write a Vision of what Blaenau Gwent should be like in 2021.
- 3.29 This is fully compliant with the actions committed to in the Community Involvement Scheme as set out in Table 1.

# Key Findings of the Issue and Vision Workshop

3.30 Issues identified in the Issues Paper consultation document were amended and prioritised in the workshop to read:

# Housing

• Create a more balanced population, stemming out-migration

 Provide a range of housing opportunities to meet aspirations including the need for affordable housing

# Transport

- To improve access to services, facilities and employment, particularly by public transport, walking and cycling
- To provide a transport system that encourages healthy and active lifestyles, is safer and supports local communities
- To improve the transport system to assist the regeneration of the area

# Employment

- The implications of the decline in the manufacturing sector and the shift in favour of the service sector and technological industries
- Changing the dependence on particular industries and diversifying the economy

# **Town Centres**

- To find a role/function for town centres
- Encourage multiple retailers and a mix of uses within the town centres specialist shops, coffee shops and offices – creating a niche market

# **Recreation Leisure and Tourism**

- To foster sustainable tourism and leisure in order to boost the local economy
- To foster sustainable tourism, re-engaging local communities with the natural and built environment

### Environment

- To protect and enhance local landscape in the face of competing development uses
- Maximise the natural environment for health and well-being.

# **Education and Skills**

- The need to improve education and skills
- 3.31 Attendees then identified the most significant issues to be addressed by the Plan. These were:
  - The implications of the decline in the manufacturing sector and the shift in favour of the service sector and technological industries;
  - The need to find a role / function for town centres;
  - The need to create a more balanced population stemming out migration; and
  - The need to provide a range of housing opportunities to meet aspirations, including the need for affordable housing.
- 3.32 The next stage of the workshop was to identify a 'Vision' for the area. All 3 groups agreed that a new Vision was required and each group drafted a Vision. From these three Visions the Planning Policy Team prepared one Vision.

# **Vision and Strategy Options Workshops**

# Purpose

3.33 The purpose of the Vision and Strategy Workshops were to:



- Share information on the Local Development Plan Vision and Strategy Options;
- Provide stakeholders with the opportunity to share views on the Vision;
- Provide stakeholders with the opportunity to influence the Council's preferred strategy; and
- Address any queries.

# When?

3.34 The Vision and Strategy Options workshops were held on three separate occasions, the first of which was held on Friday 19<sup>th</sup> October 2007 at the ViTCC and involved 11 Local Councillors. The second was held on Thursday 22<sup>nd</sup> November 2007 at the Learning Action Centre in Ebbw Vale and involved 20 attendees. The third workshop was held on Friday 30<sup>th</sup> November 2007 at the Learning Action Centre in Ebbw Vale and involved 20 attendees.

# Who?

- 3.35 All local Councillors were invited to the first workshop held in October. Individuals from the following groups (see Appendix 6) were invited to the second and third workshops:
  - Key Internal Officers
  - Statutory Consultees
  - Other Consultees
  - LDP Forum
  - Local Councillors
  - Community Groups

# How?

- 3.36 The first task provided the opportunity to amend the draft vision. Each group were then asked to identify the advantages and disadvantages of each of the three strategy options which had been prepared by Planning Policy. They were also given the opportunity to identify a further option. From the advantages and disadvantages identified the Council were able to identify the Preferred Option.
- **3.37** Participants were given the opportunity to amend the draft Vision. From these revisions the Planning Policy Team prepared a new version.

Through collaborative working, by 2021, Blaenau Gwent will become a network of sustainable, vibrant valley communities, where people have the skills, knowledge and opportunities to achieve a better quality of life and residents will live in safe, healthy and thriving communities, with access to a range of good quality affordable homes and thriving town centres. Its unique environment, cultural and historic identity will be protected and enhanced to create a place where people want to live, work and visit.

- **3.38** This workshop also discussed and identified the Preferred Strategy. Attendees were given the opportunity to identify the advantages and disadvantages of each of the options and to identify a fourth option.
- 3.39 Option 2 was the preferred option but attendees decided the following changes were needed:

- The level of growth will now identify a range of 150 to 250 and that this growth will be back-loaded (150 first 5 years, 200 next 5 year period and 250 in the final 5 year period) to the end of the Plan period.
- To address concern with protecting Greenfield sites, a specific objective will be included to develop Brownfield sites in preference to Greenfield sites.
- Option 2 will be amended to ensure that the new roles for the town centres will be complementary.
- In developing Option 2 to create the Preferred Strategy, the issues considered to be missing such as; integrated transport, tourism, health, education and community facilities will be fully addressed.
- 3.40 The revised preferred option, following amendments was:

**Option 2: Growth and Regeneration** 

- This is a growth strategy, which has the following aspects:
- Emphasis of growth would be in the Heads of Valleys and a regeneration focus in the south of the borough
- Stems out-migration leading to an increase in population to 71,000
- A house build rate of 150-250 per annum (back-loaded)
- New employment opportunities to broaden offer
- A new hierarchy of town centres, with Ebbw Vale becoming the regional centre, and Tredegar, Brynmawr and Abertillery becoming district shopping centres. Blaina would become a local shopping centre.
- Specific complementary roles would be identified for town centres, which are currently in decline, in an attempt to encourage their growth.
- 3.41 This is fully compliant with the actions committed to in the Community Involvement Scheme as set out in Table 1.

# How the Responses informed the Preferred Strategy

- 3.42 The key findings from the stakeholder engagement activities at the pre deposit participation stage are presented in more detail in the Blaenau Gwent Local Development Plan Visioning Report (March 2008) and Blaenau Gwent Local Development Plan Preferred Options Report (March 2008). A report of each workshop has also been prepared. Copies of the reports are available from the Council's website www.blaenau-gwent.gov.uk.
- 3.43 Building consensus at the early stages of the Plan production was beneficial to the process. Stakeholder engagement at this stage proved worthwhile in clarifying the main issues that the Deposit Plan needed to address and provided a significant steer in the production of the Preferred Strategy.

# Stage 2: Pre Deposit Consultation (Regulation 15 and 16) the Preferred Strategy

### Purpose

- 3.44 The principal aim of this stage was to formally consult on the 'Preferred Strategy', which set out:
  - The vision and objectives;

- The preferred strategy option;
- The strategic policies;
- The key diagram, showing the areas in the County Borough that will be affected; and
- The monitoring system.

### When?

3.45 The statutory 6-week consultation period was undertaken between Friday 7<sup>th</sup> November and Friday 19<sup>th</sup> December 2008.

# Who?

3.46 Over 500 contacts on the Blaenau Gwent consultation database received information on the LDP Preferred Strategy. A further 2,000 Blaenau Gwent local authority employees also received e-mail notification of the consultation. However, the Council were unable to consult with the Local Forum as the Forum disbanded and were not replaced. However, a large number of officers were asked for their views on the document to ensure there are no areas of concern before the document was published.

### How?

- 3.47 The package of documents published on the 7<sup>th</sup> November 2008 comprised of:
  - Draft Preferred Strategy
  - Initial Sustainability Appraisal Report
  - Candidate Site Register
  - Habitat Regulation Assessment
  - Population and Housing Background Paper
  - Employment Background Paper
  - Draft Preferred Strategy Summary Leaflet
  - Comment Forms
  - Notification of Interest Form
- 3.48 Copies of the published documents were hand-delivered to the Planning Division of the Welsh Assembly Government on Friday 7<sup>th</sup> November 2008. Electronic copies of the above documents were sent on CD, to Statutory Consultation Bodies and the LDP Forum listed in Appendix 1. Copies of the documents were available at each of the exhibition venues, and were also available for inspection by the public, free of charge at:
  - All Public Libraries in Blaenau Gwent
  - Council Website
  - Municipal Offices, Ebbw Vale
  - Business Resource Centre, Tredegar
  - Planning Control Council Offices, Blaina
  - Connect 2Blaenau Gwent (C2BG) Drop in Venues
- 3.49 Enquires were dealt with by planning policy staff at the public counter of the Regeneration Division, by telephone and by e-mail.
- 3.50 Notification letters, a Draft Preferred Strategy Summary Leaflet and a Comment Form were sent to Other Consultees on the consultation list (see Appendix 1).



- 3.51 Copies of the Preferred Strategy were also sent to 57 Officers of Blaenau Gwent County Borough Council via email and a hard copy of the Draft Preferred Strategy was sent to Local Councillors.
- 3.52 E-mail notification was sent to everyone on Blaenau Gwent's internal email directory. Public notices, and a press release were placed in the Gwent Gazette on 5<sup>th</sup> and 12<sup>th</sup> November 2008, a letter regarding the consultation of the Preferred Strategy was published in the Gwent Gazette on 3<sup>rd</sup> December 2008. Prior to formal consultation a press article was placed in the October edition of the Blaenau Gwent community magazine 'Connect' which is delivered to every household in the Borough. A copy of the public notice, press releases, letter and Connect article are attached at Appendix 11A-D.
- 3.53 Particular care was taken to ensure that the hard to reach groups identified in the LDP Delivery Agreement were involved in the process. Council officers gave presentations to a number of organisations including the Youth Forum, Housing Forum and the Access for All Forum. Notification letters and summary leaflets were sent to all hard to reach groups. These groups were also targeted through the location of exhibitions. An interview was also undertaken with Brynmawr Radio FM on the Preferred Strategy.
- 3.54 The context for the formal consultation at this stage is set out in the Council report entitled: Local Development Plan Draft Preferred Strategy: Regulation 15 Statement of Consultation (February 2009). Copies of this document are available on request.
- 3.55 A series of 18 exhibitions (Table 3) were organised around the County Borough during October and November 2007 to provide Members of the public with the opportunity to speak to a planning officer at a local venue. A poster advertising the exhibitions is attached at Appendix 12A.

- 3.56 Each exhibition was held at varying times of the day to encourage maximum participation. The aim was to reach a cross section of people, this was achieved through targeting the location and timing of the exhibitions to coincide with group activities being held at venues. (e.g. Slimming Clubs, Supermarkets, OAP Lunch Clubs, Citizen Advice Bureau Sessions etc).
- 3.57 Each session was held with two planning officers in attendance. All consultation material, site-specific and explanatory information were made available at each session.
- 3.58 Posters advertising the exhibitions were placed in the venue, on nearby lampposts and in local shops prior to the events. An example of a poster used to advertise an exhibition is attached at Appendix 12B. A list of where the posters were displayed, within each ward and how many, is contained in Table 4. The aim was to encourage as many people as possible to attend the exhibitions, raise public awareness to engage with them, and stimulate interest in the Preferred Strategy within the local community.

3.59 Apart from the disbandment of the Local Forum, the consultation carried out followed the requirements of the Council's approved Delivery Agreement as set out in Table 1.

### **Responses to the Preferred Strategy Consultation**

- 3.60 This was the key stage for communities to help shape the Deposit Plan and the main thrust of community involvement took place during this time. Members of the Public were requested to make representations in respect of the Preferred Strategy to the Council in writing.
- 3.61 There was no fundamental challenge or presentation of new evidence against the Preferred Strategy that significantly undermined it. When asked if respondents broadly agreed with the Preferred Strategy (option 2) 80% agreed. Wherever possible all issues/comments raised through consultation have been dealt with in the Deposit Plan.
- 3.62 In total 414 representations from 58 respondents were received in respect of the Preferred Strategy. Of the total, 278 representations offered comment, 136 were expressing support. The following section of the report summarises the nature of the comments received.

# Key Findings of the Preferred Strategy Consultation

3.63 The key findings to emerge from the public consultation stage are presented in more detail in the Preferred Strategy Report of Findings (February 2009) but are summarised below.

# **Stage 3: Deposit Plan Consultation (Regulation 17-21)**

# Purpose

3.64 In May 2011, Blaenau Gwent County Borough Council placed on deposit the draft LDP. The purpose of this stage of the plan was to enable all interested parties and organisations to make representations in respect of any polices and proposals in the Deposit Plan.

# When?

3.65 The Council approved the Deposit Blaenau Gwent Local Development Plan for consultation on the 15<sup>th</sup> April 2011 in accordance with the previously approved and updated Delivery Agreement (January 2011). The Deposit Plan was placed on deposit for a six week period of consultation between 5<sup>th</sup> May and 16<sup>th</sup> June 2011.

# Who?

3.66 Notification letters, comment forms, guidance notes and a summary leaflet were sent to approximately 530 different contacts on the Council's LDP database. This included statutory consultees, non-statutory consultees, the LDP steering Group and members of the public. The consultation list is contained in Appendix 1.

# How?

- 3.67 The package of documents published on the 5<sup>th</sup> May 2011 comprised:

- 3.68 A CD disc with electronic copies of the above documents was sent to statutory consultees and members of the LDP Steering Group. Hard copies of the Deposit Draft LDP were hand delivered to the Planning Division of the Welsh Government on 5<sup>th</sup> May 2011.
- 3.69 During the deposit consultation, all of the above documents were made available at:
  - All local libraries
  - Business Resource Centre, Tafarnaubach Industrial Estate, Tredegar
  - Council Municipal Offices, Civic Centre, Ebbw Vale
  - Planning Control, Council Offices, High Street, Blaina
  - Anvil Court, Abertillery
  - All Community First offices
  - Ebbw Vale Development Trust
  - The Council's website
- 3.70 The package of Deposit Draft LDP documents was published on the council's website on 5<sup>th</sup> May 2011. The Deposit Draft LDP documents were placed on the Council's website for inspection/downloading and were available throughout the consultation process. The website contained full details of the Deposit Draft LDP including information on exhibitions, links to related LDP documents and advice on how to make representations including a guidance note on submitting 'New Alternative Sites'. There was a direct link from the Council's home page to the Deposit Draft LDP throughout the consultation period.
- 3.71 A Statutory notice was placed in the Gwent Gazette on the 28<sup>th</sup> April 2011. A copy of the statutory notice is contained in Appendix 13.
- 3.72 Site notices were erected in prominent locations around sites allocated for development between 4<sup>th</sup> and 5<sup>th</sup> May 2011. An example of a site notice is attached at Appendix 14.
- 3.73 Every household in Blaenau Gwent was sent a poster advertising the forthcoming deposit plan consultation event, explaining the purpose of the consultation, how they could get involved and provided contact details for the Council's planning policy team. The poster is attached at Appendix 16A.

16

- 3.74 Articles informing residents of the Deposit Draft LDP were also placed in the Gwent Gazette. In addition, a number of press releases were published in the Gwent Gazette and South Wales Argus during the consultation period. These are attached at Appendix 15.
- 3.75 The Deposit consultation involved a number of drop in sessions that were held in each of the four main town centres as shown in Table 6. The drop in sessions were held in vacant town centre shops or well used public buildings located in the town centre for 3 consecutive days on a Thursday, Friday and Saturday to encourage maximum participation. Each of the sessions had at least two officers in attendance and all sessions held an exhibition of deposit plan information and a library of consultation material, site specific information, explanatory material, summary documents, representation forms and large scale versions of the proposals maps.
- 3.76 Posters advertising the consultation and drop in sessions were displayed in shops and notice boards in each of the 4 main town centres throughout the consultation period (See Appendix 16B).

- 3.77 Particular care was taken to ensure that the hard to reach groups were involved in the process. Council Officers gave a presentation to the Youth Forum, and met with the gypsy and traveller community and a representative from the access for all forum. Notification letters and summary leaflets were sent to mental health, elderly persons, ex offenders, and homeless organisations and to the equal opportunities commission.
- 3.78 The Council have undertook a Health Impact Assessment and an Equalities Impact Assessment on the draft Local Development Plan. The purpose of the Health Impact Assessment was to discuss the proposed strategy in terms of its negative and positive impacts on the health and well being of the Blaenau Gwent population.

The Equalities Impact Assessment assessed if the Local Development Plan helps the Council to achieve its legal duties in respect of equality. Detailed reports on these assessments are available on the Council's website.

- 3.79 All deposit representations received an acknowledgement letter which acknowledged receipt of the representation received and advised of forthcoming stages and the Examination in Public and Alternative Sites Consultation. In July 2011, a hard copy of the deposit plan representations were distributed to the Business Resource Centre, Tredegar; Planning Control Offices, High Street, Blaina; the Civic Centre, Ebbw Vale; and Anvil Court, Abertillery. Deposit Plan representations were scanned and uploaded on the website in July 2011.
- 3.80 The consultation on the Deposit Draft LDP and accompanying documents followed the requirements of the Council's approved Delivery Agreement as set out in Table 1.

# **Responses to the Deposit Consultation**

- 3.81 In total 390 representations from 85 representors were received to the Deposit Local Development Plan. Of these 390 representations, 98 expressed support for the Plan.
- 3.82 Table 7 shows the number of representations received to each chapter of the Plan. It does not show a break down of all representations received because not all representations related to a specific chapter of the LDP. It does however show how the majority of representations related to allocations and designations and strategic policies contained in chapters 8 and 6 respectively.

3.83 The largest number of representations (143) were received on Chapter 8.0 Allocations and Designations and Chapter 6.0 Strategic Policies (90).



- 3.84 Of particular numerical significance in terms of the representations made to the allocations and designation chapters were allocations H1.2 Cartref Aneurin Bevan (10 representations); H1.14 Six Bells Colliery Site (11 representations); ED1.2 Lower Plateau Six Bells Colliery Site (12 representations); and M4.2 Tir Pentwys Tip Preferred Area (10 representations). Of particular note was the 111 signature petition received from two local residents in respect of the deletion of the housing and school site at Six Bells Colliery and the 171 signature petition requesting the deletion of the housing site. Two other petitions were received in respect of Jesmondene Stadium one with 19 names and the other with 3.
- 3.85 With regard to the Strategic Policies Chapters, of particular numerical significance are the representations received to policies SP3 The Retail Hierarchy and Vitality and Viability of the Town Centres (10 representations), SP4 Delivering Quality Housing (15 representations), SP10 Protection and Enhancement of the Natural Environment (11 representations).
- **3.86** Table 8 also provides a breakdown of the number of representations received which supported the Plan. Chapter 8.0 Allocations and Designations received the highest number of representations in support of the Plan (37).
- 3.87 Altogether 47 representations from 3 representors were received to the Sustainability Appraisal (SA) comprising 15 representations of support. A further 8 representations were received to the Habitat Regulation Assessment (HRA).
- 3.88 Of the total number of deposit representations, 63 alternative sites were suggested. These consisted of new sites proposed to be included in the Plan, proposed amendments to existing allocations, sites proposed for deletion from the Plan and proposed amendments to the settlement boundaries. These sites were subject to a separate consultation held in July - September 2011.

# Key Findings of the Deposit Plan Consultation

- 3.89 A number of important issues were raised to the deposit draft Local Development Plan consultation.
- 3.90 The main issues were:
  - The ability to deliver the Housing Requirement figure in light of, past completion figures, the current economic climate, deliverability of sites and questions of site viability.
  - **Mineral policies**, in particular issues over the way that coal is dealt with and consistency with other Authorities boundaries
  - Six Bells Colliery Site some objections relate to the housing and school whilst others object only to the housing. Other objectors ask for the whole site to be allocated for tourism and leisure.
  - The extent of the buffer and Preferred Area at **Trefil Quarry**
  - The extent of the green wedge between Tredegar and Ebbw Vale and the need to protect ecological connectivity
  - Objections to specific proposals, principally housing sites.
  - Objections from land owners, who proposed 25 additional sites and 4 amendments to the settlement boundary.

# **Stage 4: Alternative Site Consultation**

# Purpose

3.91 The purpose of this stage was to publicise the site allocation representations received during the deposit plan consultation.

# When?

3.92 The consultation was held for six weeks from the 21<sup>st</sup> July to the 1<sup>st</sup> September 2011. An addendum was issued on 28<sup>th</sup> July 2011 identifying an additional alternative site.

# Who?

3.93 Notification letters were sent to approximately 615 different contacts on the Council's LDP database. This included statutory consultees, non-statutory consultees, the LDP Forum and members of the public. The consultation list is contained in Appendix 1 and 2. These letters were sent out prior to the beginning of the consultation period and informed people about the process and how to make a representation in relation to the soundness of the Plan. Notification letters and the addendum were sent to all consultees on the LDP database on the 28<sup>th</sup> July 2011.

# How?

3.94 Of the total number of deposit representations, 63 alternative sites were suggested. These were new sites proposed to be included in the Plan or proposed amendments to existing allocations or sites proposed for deletion from the Plan or proposed amendments to the settlement boundaries. Table 8 provides a breakdown of the different types of alternative site proposals submitted. 8 of these were previously submitted as candidate sites and 17 were completely new sites, not previously considered.

3.95 The consultation involved the publication of an alternative sites register. The alternative sites register provided information about the alternative sites received. The Alternative Sites Register is structured into four parts as follows:

**PART A**: New sites proposed to be included in the Local Development Plan

**PART B:** Proposed amendments to existing LDP allocations

PART C: Site proposed for deletion from the Local Development Plan

**PART D:** Proposed amendments to the settlement boundaries in the Local Development Plan

- 3.96 The register explained what the consultation involved, and how to make a representation. Copies of the register were available at:
  - All local libraries

- Business Resource Centre, Tafarnaubach Industrial Estate, Tredegar
- Council Municipal Offices, Civic Centre, Ebbw Vale
- Planning Control, Council Offices, High Street, Blaina
- Anvil Court, Abertillery
- All Community First offices
- Ebbw Vale Development Trust
- 3.97 The register was also placed on the website during the 6 week consultation period from 21<sup>st</sup> July through to 1<sup>st</sup> September 2011.
- 3.98 An addendum to the alternative site register included an additional site that had been omitted from the alternative sites register. This additional site (AS (A) 18) was found at the start of the consultation period and therefore the consultation period was not extended.
- 3.99 Copies of the alternative site register were hand delivered to the Planning Division of the Welsh Government on 21<sup>st</sup> July 2011.
- 3.100 A statutory notice was placed in the Gwent Gazette on 21<sup>st</sup> July 2011. A copy of the statutory notice is contained in Appendix 17.
- 3.101 Site notices were erected in prominent positions around the alternative sites between the 21<sup>st</sup> and 22<sup>nd</sup> July. The site notices included a map and the site reference and contact details for the department. An example of a site notice is attached at Appendix 18.
- 3.102 In accordance with the Community Involvement Scheme set out in the Delivery Agreement, drop in sessions and workshops were not considered necessary during this stage of consultation.
- 3.103 All representations on alternative sites received an acknowledgement letter advising them of the next stages and forthcoming updates. In October 2011, a hard copy of the alternative site representations were distributed to the Business Resource Centre, Tredegar; Planning Control Offices, High Street, Blaina; the Civic Centre, Ebbw Vale; and Anvil Court, Abertillery. Alternative site representations were scanned and uploaded on the website in October November 2011.
- 3.104 This is fully compliant with the actions committed to in the Community Involvement Scheme as set out in Table 1.

#### **Response to Alternative Site Consultation**

- 3.105 The 423 representations from 176 representors received to the alternative site consultation represented a higher response rate than the deposit plan. Of the 423 representations, 321 were objections that is they supported the position of the Plan. Of these 14 objections were received to the alternative site deletions, 281 objections were received to new sites, 15 objections were received to proposed amendments, and 11 to amendments to the settlement boundaries.
- 3.106 The overwhelming majority of objections (246) were to new alternative sites, stating that they were undevelopable and that the Plan would be unsound if they were

included. Those representations supporting the alternative sites have largely come from the landowners promoting their own site. All representations received are contained in the Report of Representations document which can be found at Appendix 22.

3.107 Table 9 shows the spatial distribution of the new alternative sites proposed for residential development. The majority of sites are located outside the settlement boundary and are therefore contrary to the LDP Strategy of directing development to brownfield land within the settlement limits.

# Key Findings of the Alternative Site Consultation

- 3.108 The key issues that arose from the alternative sites consultation related to the new sites proposed for residential development and existing housing allocations.
  - New Sites proposed for residential development
- 3.109 Over 75% of the representations received at the alternative site consultation stage were objections to the new sites. Extensive representations were made to AS (N) 04 Land at Big Lane Site 6 and AS (N) 05 Land off Parkhill Crescent.
- 3.110 All new sites were discounted for inclusion in the Plan for residential development. The sites were considered undevelopable with the majority of them being located outside the settlement boundary and therefore contrary to the LDP strategy.
  - Existing Housing Allocations
- 3.111 Supporting information and further work was undertaken at this stage as a result of the representations received on housing allocation H1.4 (Alternative Site Ref AS (D) 02) Jesmondene Stadium. An unresolved land stability issue was identified with the landowner and the Council and concerns regarding land contamination raised questions of the site's viability and deliverability, it is therefore proposed to delete the site from the plan. This is advertised as a focussed change.
- 3.112 An extensive number of representations were received in support of the deletion of housing allocation H1.5 (Alternative Site Ref AS (D) 03) Business Resource Centre from the Plan during the alternative site consultation stage. Issues of concern were raised around the loss of employment land and the loss of character of the village. The Council propose to delete the site from the Plan and advertise as a focussed change.

# 4.0 **REPRESENTATION RESPONSES**

4.1 In accordance with the requirements of the LDP Regulations, the Council has

considered each of the representations received at the Deposit and Alternative Site stage and formulated a response. A summary of each of the representations received and the Council's response is contained in the Report of Representations. The changes proposed as result of the representations are contained in the LDP Statement of Focussed Changes.

- 4.2 The representations made on the Deposit Local Development Plan and on the Alternative Sites were reported to Members during a series of Member meetings held in October and November 2011. These meetings enabled members to voice concerns regarding the issues raised and be briefed on the next steps.
- 4.3 The Deposit Plan and Alternative Site consultation responses were reported to Regeneration and Housing Scrutiny on 7<sup>th</sup> December 2011, Executive on 14<sup>th</sup> December 2011 and Full Council on 5<sup>th</sup> January 2012. A meeting with the LDP Forum was not held due to the lack of interest with only 3 people expressing an interest in attending the meeting.
- 4.4 The report taken through the committee process set out the key findings arising from the deposit plan consultation. The Report of Representations was attached as an appendix and detailed the representations received. A separate report proposing the consequent changes to the Plan known as the Statement of Focussed Changes was also reported.

# 5.0 ANALYSIS OF REPRESENTATIONS

- 5.1 As Section 3.0 indicates, in total the Council received 813 representations in respect of the Deposit Draft LDP and Alternative Site Allocations. In addition a total of 117 late 'not duly made' representations were received. The following section provides an identification of the main areas for consideration at examination.
- 5.2 The analysis of the representations received to the Deposit Draft LDP and the Alternative Site allocations indicates clearly the primary areas of objection and therefore the main areas for consideration at the Local Development Plan examination.
- 5.3 The Council's suggested areas for consideration at the examination are:
  - Strategy
  - Housing requirement figure and deliverability
  - Housing allocations and settlement boundaries
  - Minerals
  - Six Bells Colliery Site

### Strategy

- 5.4 The Spatial Strategy and policies SP1 and SP2 provide a strategic framework for development in Blaenau Gwent. Key issues identified through the representations to the Deposit Draft LDP include:
  - Emphasis on Ebbw Vale
  - Lack of reference to the environment
  - Questions regarding impact of the hub approach

- 5.5 Following consideration of the key issues identified above, the Council proposes not to amend the Spatial Strategy, SP1 and SP2.
- 5.6 The Council recommends to the Planning Inspector that because of the local significance of the issues raised that the matter may need to be considered further at a round table session of the examination.

# Housing Requirement Figure and Deliverability

- 5.7 Policies SP4, SP5 and H1 provide a framework for the delivery of new housing in Blaenau Gwent. Key issues identified through the representations to the Deposit Draft LDP include:
  - Deliverability and flexibility of housing requirement figure
  - Deliverability of housing sites
  - Accuracy of the housing requirement figure
  - Phasing does not accord with national policy
- 5.8 Following consideration of the representations the Council proposes to amend policies SP4, SP5 and H1 and objectives 2 and 3.
- 5.9 The Council recommends to the Planning Inspector that because of the significance of the issues raised that the matter may need to be considered further at a round table session of the examination.

### Housing allocations and settlement boundaries

- 5.10 Policies H1 and SB1 provide a new framework for the delivery of new housing in Blaenau Gwent and defines a settlement boundary. Of the 22 housing allocations, 14 were objected to. In addition 15 new sites were promoted for housing development and 4 amendments proposed to the designated settlement boundaries. Key issues identified through the representations to the Deposit Draft LDP include:
  - The allocation of certain parcels land for housing
  - The definition of settlement boundaries
- 5.11 Following consideration of the representations the Council proposes to delete allocations H1.4 and H1.5 and amend the settlement boundary.
- 5.12 The Council recommends to the Planning Inspector that because of the significance of the issues raised that the matter may need to be considered further at a round table session of the examination.

### Minerals

- 5.13 Policies SP12, DM19, DM20, M1, M2, M3 and M4 provides a framework for the protection of mineral resources in Blaenau Gwent. Key issues identified through the representations to the Deposit Draft LDP include:
  - The apportionment should be raised to 6Mt to absorb BBNP requirement
  - Identification of tertiary and coal resources
  - The identification of the preferred area of known mineral resource at Trefil Quarry
  - The identification of the preferred area of known mineral resource at Tirpentwys

- 5.14 Following consideration of the representations the Council proposes that amendments be made to policies DM19 and DM20; and that the proposals map is amended to delete part of the Preferred Area at Trefil Quarry and that the buffer be amended around the Preferred Area.
- 5.15 The Council recommends to the Planning Inspector that because of the significance of the issues raised that the matter may need to be considered further at a round table session of the examination.

# Six Bells Colliery Site

- 5.16 Policies H1.14 and ED1.2 allocates land at the former Six Bells Colliery site for housing and a primary school. A number of objections were received as well as 3 petitions.
- 5.17 The key issues identified through the representations in respect of the housing development proposed at this site include:
  - Amend the boundary of the allocation to include the former Aberbeeg Junior School site
  - Objection to housing due to its impact on highways; biodiversity; landscape; the surrounding area and existing local infrastructure. In addition objections were raised around the following: questions the need for housing; the site would be better used for a primary school; valuable recreational and tourist destination; loss of open space; contrary to the Six Bells Regeneration Strategy; and the site qualifies as a rural exception site.
  - The site should be included as a tourism and leisure allocation.
- 5.18 The key issues identified through the representations in respect of the primary school proposed at the site include:
  - Objection to the primary school on the grounds of the site is located in flood zone C2; and SFCA has not demonstrated that the consequences of flooding are capable of being managed.
  - The site should be retained for tourism and leisure.
- 5.19 Following consideration of the representations, the Council proposes not to amend policy H1.14. With regard to the results of the SFCA, it is proposed to amend the site boundary of allocation ED1.2.
- 5.20 The Council recommends to the Planning Inspector that because of the local significance of the issues raised that the matter may need to be considered further at a round table session of the examination.

# 6.0 FOCUSSED CHANGES

### Purpose

6.1 In January 2011, Blaenau Gwent County Borough Council made the Focussed Changes available for public consultation. The purpose of this stage was to consult on the changes that the Council considers appropriate to make to the Local Development Plan following consideration of the representations.

### When?

6.2 The Focussed Changes were published for public consultation for six weeks on 19<sup>th</sup> January until 1<sup>st</sup> March 2012.

# Who?

6.3 Notification letters were sent to approximately 770 different contacts on the Council's LDP database. This included statutory consultees, non-statutory consultees, the LDP Forum and members of the public. The consultation list is contained in Appendix 1, 2 And 3. Copies of the Focussed Changes documents were hand delivered to the Planning Division of the Welsh Government on 19<sup>th</sup> January 2012.

# How?

- 6.4 The package of documents forming the Focussed Changes consultation comprised of:
  - Statement of Focussed Changes
  - Representations Form
  - A CD containing the above documents was sent to the statutory consultees.
- 6.5 The following documents were also published for information on the Council's website:
  - Report of Consultation
  - Updated Sustainability Appraisal
  - Preliminary Results of Hydraulic Modelling Study
- 6.6 All documents were published on the Council's website on 19<sup>th</sup> January 2012 and were made available at:
  - All local libraries
  - Business Resource Centre, Tafarnaubach Industrial Estate, Tredegar
  - Council Municipal Offices, Civic Centre, Ebbw Vale
  - Planning Control, Council Offices, High Street, Blaina
  - Anvil Court, Abertillery
  - All Community First offices
  - Ebbw Vale Development Trust
- 6.7 A Statutory notice was placed in the Gwent Gazette on the 19<sup>th</sup> January 2012. A copy of the Statutory Notice is contained in Appendix 19.
- 6.8 Site Notices advertising proposed amendments and deletions of allocations were erected in prominent locations around the sites. An example of a site notice is attached at Appendix 20.

# 7.0 SUSTAINABILITY APPRAISAL / STRATEGIC ENVIRONMENTAL ASSESSMENT

7.1 As part of the LDP preparation process there has been an iterative process of Sustainability Appraisal (incorporating the requirements of the European Directive

'Strategic Environmental Assessment' – SA/SEA) which has its own legislation and consultation requirements. The results of this consultation have informed the production of the plan and are covered in a separate Sustainability Appraisal Report which is available on request and on the council's website <u>www.blaenau-gwent.gov.uk</u>.

# **Pre Deposit Participation and Consultation**

- 7.2 Early engagement with the statutory SA/SEA consultees and key stakeholders were necessary to set the context and objectives, establish a baseline and decide the scope for the appraisal against which the LDP has been assessed. Formal consultation with stakeholders on the Scoping Report took place for a statutory 5-week period between 9 November 2007 and 14 December 2007.
- 7.3 The stakeholders engaged during this stage were:
  - Statutory Consultees
  - Adjoining Local Authorities
  - Environmental Organisations
  - Town and Community Councils
  - Other Interested Parties (e.g. NHS Trust, Voice of Industry, Local Chambers of Commerce)
  - LDP Forum a representative group comprising private and public sector housing; voluntary groups; Local Health Board; Private Sector Enterprises; Private Sector Companies; and Education.
- 7.4 A workshop was held on the 24<sup>th</sup> April 2009 with the SA/SEA working group to discuss/agree the changes to the SA/SEA report as a result of consultation.
- 7.5 Subsequently an Initial Sustainability Appraisal Report was produced and was issued for consultation alongside the LDP Preferred Strategy from 7<sup>th</sup> November 2008 to 19<sup>th</sup> December 2008. The stakeholders engaged during this stage are listed in Appendix 1. A copy of this report was made available to the public and is available on the council website.

### **Deposit Plan Consultation**

- 7.6 The Sustainability and Strategic Environmental Assessment Report formed one of the core documents placed on Deposit in May 2011. Proposers of new or alternative sites were asked to submit information to demonstrate how the site complied with the sustainability appraisal. A guidance note for new and alternative sites was published at the deposit stage.
- 7.7 47 representations from 3 representors were received to the Sustainability Appraisal (SA) comprising 15 representations of support. The two key issues that arose out of the consultation was:
  - Compatibility of sites with SA objectives
  - Assessment of significant effects of Strategic, Development Management, Allocations and Designations Policies
  - Compatibility of sites with SA objectives
- 7.8 It is acknowledged that during the candidate site assessment work that some data gaps exist for some data such as air quality and greenhouse gas emissions, as it

was uncertain as to the potential effects of the site in relation to these objectives, as outcomes are dependent on a number of factors including the implementation of other policies in the plan including ones relating to sustainable transport. While the comment refers to a number of sites scoring negatively against the SA objectives (a 'red' score), only 10 of the sites carried forward were allocated a 'red' score. Sites carried forward are those with a colour on the left hand column (indicating the type of allocation in the site descriptions document). It is agreed, however, that for these sites, and the sites carried forward where insufficient information was available for the assessment, that this data is added into the SA tables.

- Assessment of significant effects of Strategic, Development Management, Allocations and Designations Policies
- 7.9 Although the SA Report provides a summary of the assessment, the assessment of effects has been fully considered in the recommendations arising from these assessments. Although not included in the chapter specifically, readers are referred to the appendices for further detail if they require additional information as to the reasoning behind the recommendations made in the main report (including the prediction of significant effects). Where a range of both positive and negative significant effects is predicted in the assessments, this is also recorded in the main report and included in the monitoring framework
- 7.10 63 out of the 390 deposit representations put forward alternative sites. Representors who had submitted sites but had not provided any specific information for the sustainability appraisal were made aware that they needed to submit additional information.

### **Alternative Sites**

7.11 The alternative sites submitted at deposit were subject to a separate consultation held in July-September 2011. These alternative sites were assessed against the Sustainability Appraisal Objectives following the methodology undertaken at stage 5 of the candidate site assessment process. A number of the alternative sites had been submitted as candidate sites and failed stage 2 of the 5 stages of the methodology. 17 of the alternative sites were new sites not previously submitted.

#### **Focussed Changes**

7.12 The schedule of focussed changes are changes that have been proposed to the Deposit Plan as a result of the representations received at deposit and alternative site consultation. None of these changes are fundamental and go to the heart of the plan. Two types of changes are proposed. Focussed changes which are changes that have resulted from outcomes of consultation or key pieces of evidence that do not affect the soundness of the plan, and minor changes which have no impact on Plan's soundness. These changes have been subject to the same considerations in respect of the SA/SEA as the original deposit LDP. The focussed changes and potential impact or reassessment of plans and policies have been published in an updated Sustainability Appraisal Report and was published as part of the Focussed Change consultation.

# 8.0 HABITAT REGULATION ASSESSMENT

8.1 In line with the requirements set by the Conservation (Natural Habitats &c) (Amendment) Regulations 2007, the Council has undertaken a Habitat Regulation Assessment. The Assessment was based on the formal Welsh guidance and practice. The results of the Habitat Regulation Assessment have informed the production of the plan and are covered in separate Habitat Regulation Assessment Reports which are available on request and on the Council's website <u>www.blaenau-gwent.gov.uk</u>.

# **Pre Deposit Consultation**

- 8.2 The first process of the Habitat Regulation Assessment was to undertake a screening exercise. This was undertaken at the Preferred Strategy stage of the Local Development Plan. The screening exercise addressed the likely significant effects on designated European Sites of implementing the policies and proposals of the Draft Preferred Strategy.
- 8.3 Subsequently a Habitat Regulation Assessment Screening Report was produced and was issued for consultation alongside the LDP Preferred Strategy from 7<sup>th</sup> November 2008 to 19<sup>th</sup> December 2008. The stakeholders engaged during this stage are listed in Appendix 1. A copy of this report was made available to the public and is available on the Council website.

### **Deposit Plan Consultation**

- 8.4 A new screening exercise was undertaken for the Deposit Plan which assessed the likely significant effects of the Deposit Plan on "5 European Sites" within its area of influence, and those that the plan is not directly connected with or necessary to the management of these sites. An appropriate assessment was undertaken of the implications of the Deposit Plan in view of the sites' conservation objectives.
- 8.5 Subsequently the Habitat Regulation Assessment Screening Report and Appropriate Assessment Reports formed two of the core documents placed on deposit in May 2011. 8 representations from 2 representors were received to the Habitat Regulation Assessment.
- 8.6 The key issue that arose out of the consultation was:
  - Additional caveats are included within the relevant allocation details in Chapter 9.0

It is agreed that the Survey Requirements table in Chapter 9.0 be expanded to include all allocations and that an additional column is included to identify where a HRA assessment is required and that the site descriptions document is updated.

### Focussed Changes

8.7 The schedule of focussed changes are changes that have been proposed to the Deposit Plan as a result of the representations received at deposit and alternative site consultation. None of these changes are fundamental and go to the heart of the plan. Two types of changes are proposed. Focussed changes which are changes that have resulted from outcomes of consultation or key pieces of evidence that do not affect the soundness of the plan, and minor changes which have no impact on

Plan's soundness. These changes have been subject to the same considerations in respect of the HRA as the original deposit LDP. The focussed changes and potential impact or reassessment of plans and policies have been published in a separate report on the Habitat Regulations Assessment of the Focussed Changes.

### 9.0 SOUNDNESS SELF ASSESSMENT

- 9.1 Planning guidance advises local planning authorities to submit LDPs for examination that they consider to meet all test of soundness.
- 9.2 In order to demonstrate the soundness of the LDP the Council has conducted its own assessment of the soundness. Attached as Appendix 21 are the results of the Council's self assessment.

When the Council formally adopted its Unitary Development Plan (UDP) last year, it became one of only seven Authorities in Wales to do so. However, changes in Government legislation now mean that the UDP must be replaced with a Local Development Plan (LDP) within the next four years.

The LDP will set out what kind of development can take place in the County Borough and will contain the policies that will be used to determine planning applications in the future These policies will decide which areas of land can be used for housing, employment, retail leisure, recreation and tourism, transport and open space.

The plan has the potential to directly affect the lives of every resident in the County Borough as well as having major implications for landowners.

The first stage in plan proparation has seen the Council prepare a Delivery Agreement which sets out how and when YOU can be involved in the process. 

## APPENDIX 11B: LETTER REGARDING PREFERRED STRATEGY IN THE GWENT GAZETTE (3<sup>RD</sup> DECEMBER 2008)

### We don't think plan is fair to us

ABERTILLERY and Linhilteth Community Council Jeels it must comment on the latest Bloenan Gwent Development Plan which was published in November

This should be renamed the Ebbw Vale Development Plan as, studying it, I could see very little benefit to other communities. It seems Ebbw Vale will become the principal retail centre for the county borough.

There is provision in the plan for more than 2,000 new houses; unfortunately, 1,500 have been enmarked for Ebbw Vole, with the remainder being shared throughout the county borough. Proposals inclute a new hospital, a new learning campus, a new leisure centre and a theatre – all on the former Corta site in Ebbw Vale. It is proposed to extend the Ebbw Vale to Cardiff rail link into Ebbw Vale. With a new park and title facility A new link road from the former Corta site to the Heads of the Valley is included, together with high quality business sites far inward investment.

Obviously, Abertillery and Elanhilleth Community Council has no objections to any community benefiting from available, funding: however, members feel that all communities should receive an equal share.

If is simply not good enough for the plan to propose improved public transport and highways for a network to feed into Ebbw Vale. Communities such as ours should feature far more prominently in a development plan for the county borough of Biaenau Gwent.

For instance, this community council feels it is essential the county borought and Welsh Assembly Goverament honour their previous commitment for the spur line from Aberberg to Abertillery to be completed two years after the Ebbw Valc to Cardiff line – i.e. 2009 – thus offining our maidents a far wider choice of employment and leisure facilities.

Another item of major concern to

some of our residents is the dire lack of parking facilities alongside the A467. Other residents also have a variety of requirements which should be considered in any Bluenau Gwent development plan.

We request that the county borough commissions the same consultants who drew up the development plan to draw up a husiness import assessment on how




