OFF-STREET PARKING PLACES CONSOLIDATION ORDER 2020

AMENDMENT ORDER "B"

Blaenau Gwent County Borough Council in exercise of its powers under the Road Traffic Regulation Act 1984 ('the Act') and Part IV of Schedule 9 to the Act as amended by the Parking Act 1989, the Traffic Management Act 2004 ("the 2004 Act") and of all other enabling powers, and after consulting the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order, the effect of which will be:

1. To introduce a Control of Use Order and the Gwent Shopping Centre Car Park Tredegar.
2. To introduce Electric Vehicle parking bays within the designated named parking places, namely: - Gwent Shopping Centre Car Park within the designated area for Taxi Parking only.

The draft Map - Based Traffic Regulation Order and Statement of Reasons can be viewed online on Blaenau Gwent Council's website.

If you wish to object to the proposals you will need to send the grounds for objection in writing to the Head of Community Services, so as to be received by 4th November 2021. Any objection received after that date will not be considered.
